We lobby on behalf of all individuals who believe that public policy free of religious preference is the best way to ensure freedom of conscience for Arizonans of all faiths and of none.

We also represent the Arizona nontheistic community – a vibrant and growing community of Arizonans who self-identify as atheists, agnostics, humanists, freethinkers, and other labels of personal choosing – to elected officials and government bodies in and from Arizona. 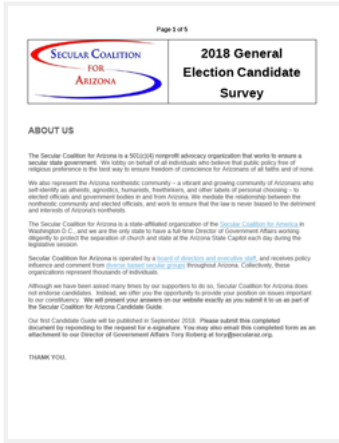
