**SB1289: SCHOOLS; NATIONAL MOTTO; STATE MOTTO**  
**What it does:** permits public schools to display or recite the national motto "In God We Trust," as well as the English translation of the Arizona state motto: *Ditat Deus*, meaning "God Enriches."  
**Our position:** Oppose  
**Final disposition:** Passed

**SB1393: DISSOLUTION; HUMAN EMBRYOS; DISPOSITION**  
**What it does:** in matters of divorce, separation, or dispute, SB1393 overrides pre-existing agreements regarding *in vitro* embryos to award control of fetuses to the parent most likely to develop them to birth.  
**Our position:** Oppose  
**Final disposition:** Passed

**SB1394: DHS; REPORTING; ABORTIONS**  
**What it does:** requires doctors performing abortions to ask women a specific reason for terminating their pregnancy, including whether the abortion is due to sex trafficking, domestic violence, rape, or incest. Requires doctors to report this information as well as details about any complications arising during the abortion to ADHS.  
**Our position:** Oppose

**SB1467: STO'S; CORPORATIONS; CAPS; SCHOLARSHIP ELIGIBILITY**  
**What it does:** expands a program which allows parents and corporations to claim tax credits for tuition paid to private non-profit schools. Raises caps on donation amounts allowed by corporations; expands eligibility to home-schooled and out-of-state students; facilitates movement between STO and ESA programs.  
**Our position:** Oppose
